

# Childcare Information

*Updated May 28th, 2020*

The SF Department of Public Health has released an [Interim Guidance for Child Care Programs and Summer Day Camps](#) to serve as a resource for communities seeking to reopen childcare facilities and summer camps.

Enrollment for childcare programs can expand enrollment to all children on June 1st, with summer day camps having the option to open for all children and youth as soon as June 15th.

## **Childcare Guidelines**



- State-licensed facilities for children ages 0-5 years will have a maximum group size of 10 children per room
- Summer day camps will have a maximum group size of 12 children or youth per room and a minimum of 2 staff per group
- Summer day camps will have a 3-week minimum session length, and sessions lasting 3 weeks long should begin and end on the following dates:

June 15 - July 2, 2020

July 6 - July 24, 2020

July 26 - August 14, 2020

- Children, youth and staff should remain in the same group, with limited to no interaction among different groups.



# Face Coverings for Children in Public and in Programs for Youth

*By order of the San Francisco Health Officer:*



## Ages (in years)

**0-2**

should not wear a face covering due to risk of suffocation

**3-12**

face coverings recommended but not required. If worn, adults must supervise use of face coverings.

**13+**

must wear a face covering
